**Minnesota Department of Human Services (DHS)**

You have the right to file a complaint with DHS if you believe you have been discriminated against in our health care programs because of any of the following:

- race
- color
- national origin
- religion (in some cases)
- age
- disability (including physical or mental impairment)
- sex (including sex stereotypes and gender identity)

Complaints must be in writing and filed within 180 days of the date you discovered the alleged discrimination. The complaint must contain your name and address and describe the discrimination you are complaining about. We will review it and notify you in writing about whether we have authority to investigate. If we do, we will investigate the complaint.

DHS will notify you in writing of the investigation's outcome. You have the right to appeal if you disagree with the decision. To appeal, you must send a written request to have DHS review the investigation outcome. Be brief and state why you disagree with the decision. Include additional information you think is important.

If you file a complaint in this way, the people who work for the agency named in the complaint cannot retaliate against you. This means they cannot punish you in any way for filing a complaint. Filing a complaint in this way does not stop you from seeking out other legal or administrative actions.

American Indians can continue or begin to use tribal and Indian Health Services (IHS) clinics. We will not require prior approval or impose any conditions for you to get services at these clinics. For elders age 65 years and older this includes Elderly Waiver (EW) services accessed through the tribe. If a doctor or other provider in a tribal or IHS clinic refers you to a provider in our network, we will not require you to see your primary care provider prior to the referral.

Enrolling in this health plan does not guarantee you can use a particular provider on this list. If you want to make sure, call that provider to ask whether he or she is still part of this health plan. Also ask if he or she is accepting new patients. This health plan may not cover all your health care costs. Read your Member Handbook carefully to find out what is covered.

## Program Descriptions

---

**Families and Children:** Families and Children is a managed care program that covers health care for the following people who have Medical Assistance:

- Children under the age of 21
- Parents and caretakers of a dependent child
- Pregnant women
- Adults without a dependent child

Our Families and Children program is called **Medical Assistance**.

**MinnesotaCare:** MinnesotaCare is a managed care program that covers health care for people who do not have access to affordable health care coverage. Some members may be required to pay a premium to the state.

**Minnesota Senior Care Plus (MSC+):** MSC+ is a managed care program that covers health care and Elderly Waiver services for people who:

- are age 65 or over and
- have Medical Assistance.

If you are enrolled in MSC+, you may have another option. Contact your county financial worker to check if you can enroll in the Minnesota Senior Health Options (MSHO) program. MSHO is a voluntary program.

**Special Needs BasicCare (SNBC):** SNBC is a voluntary managed care program that covers health care for people with disabilities who:

- are age 18 through 64, \*
- have Medical Assistance and
- have either both Medicare Parts A and B or Medical Assistance only.

\* People in SNBC who turn 65 will be enrolled into a senior managed care program if they continue to meet the eligibility criteria to remain in managed care.

Our SNBC programs are called **SingleCare** and **SharedCare**.

- SingleCare (SNBC) provides Medical Assistance benefits for those not eligible for Medicare.
- SharedCare (SNBC) provides only Medical Assistance benefits for those that are eligible for Medicare benefits but get them from other health plans.

## Introduction

---

South Country Health Alliance (also referred to as South Country) is a county-owned health plan that serves 8 Minnesota counties. Through South Country, these counties have joined together to help improve how you receive your health care. Clinics, doctors, dentists, eye doctors, chiropractors, hospitals, nursing homes and home care agencies are working with us to make sure that you get the best care.

The 8 counties in our service area include: Brown, Dodge, Goodhue, Kanabec, Sibley, Steele, Wabasha and Waseca. We work closely with county health care providers, human service agencies and county public health departments in these counties to support your wellness. South Country has five different programs to meet our members' health care needs.

### How to find network providers in your area

The Home Care and Personal Care Provider Agencies (PCAs) in this directory are organized by state, county and city. If you have questions or require assistance in finding a provider, please call our Member Services Department at the phone number listed on the front cover of this book. We also have a main directory and an online search which can be found on our website at [www.mnscha.org](http://www.mnscha.org). You can get this subdirectory or the main directory in print at no cost using the online request form or by calling Member Services. The main directory lists the following types of providers: Primary Care, Dentists, Early Intensive Developmental and Behavioral Intervention (EIDBI) Services, Hospitals, Housing Stabilization Providers, Mental Health, Pharmacies, Substance Use Disorder (SUD) Providers, Urgent Care and After Hours Care and Specialists.

You must get all of your health care from South Country network providers. There are some exceptions. Examples of exceptions are: emergency or urgent care, open access services and other previously authorized services. If you have questions about the providers you should use, please contact Member Services at the phone number listed on the front cover of this book.

### **How to access specialty providers**

You can use any provider in our network without referral, including specialists. This subdirectory contains listings for Home Health and Personal Care Provider Agencies (PCPA). Our main directory contains other specialists. The Table of Contents in the main directory has specialties listed alphabetically. Locate the specialty you want then refer to that page. The listing is organized by state, county, city and facility name.

### **How to access emergency care**

**In an emergency that needs treatment right away, either call 911 or go to the nearest emergency room.** You do not need to get approval first from your primary care provider. But, please call your primary care clinic as soon as possible. You may get covered emergency medical care whenever you need it, anywhere in the United States or its territories. Our plan covers ambulance services in situations where getting to the emergency room in any other way could endanger your health.

### **How to access urgently needed services**

“Urgently needed services” are a non-emergency, unforeseen medical illness, injury, or condition, that requires immediate medical care. Urgently needed services may be furnished by network providers or by out-of-network providers when network providers are temporarily unavailable or inaccessible.

You should always try to obtain urgently needed services from network providers. We will also cover urgently needed services from an out-of-network provider when it is not reasonable to wait to obtain care from a network provider.

Network urgent care centers are not listed in this directory. They can be found in the main directory or the online search at [www.mnscha.org](http://www.mnscha.org). If you cannot find an urgent care center in your area, or have questions, call Member Services at the phone number printed on the front cover of this book.

### **How MSC+ members can get more information about Home and Community Based Service providers**

Home and Community Based Service Providers are not listed in this directory. South Country uses the DHS Open Network for these providers. Visit <https://mhcpproviderdirectory.dhs.state.mn.us/> **Note:** The DHS Open Network directory may not have all home and community-based providers listed. Visit [MinnesotaHelp.info](#) for more home and community-based services and waiver providers. To find out more about these services, refer to your Member Handbook. These services may be accessed through your care coordinator as part of your care plan. Call your care coordinator if you need a listing of providers or more information about how to access these services. If you have additional questions, call Member Services at the phone number listed on the front cover of this book.

### **How MSC+ members can get more information about Long Term Services and Supports**

You may be able to get long-term services and supports (LTSS), such as services provided by the Elderly Waiver (EW) program as a South Country Health Alliance member. Long-term services and supports are help for people who need assistance to do everyday tasks like taking a bath, getting dressed, making food and taking medicine. Most of these services are provided at your home or in your community but could be provided in a nursing home or hospital. To find out more about these services, refer to your Member Handbook. Call Member Services at the phone number listed on the front cover of this book to get more information on how to access these services.

## How to find a network pharmacy

Enrollees with Medicare must use a Medicare Part D prescription drug plan for Part-D covered drugs. Contact your Medicare Part D prescription drug plan if you have questions about how to access Part D drugs.

### Care Coordination

MSC+, SharedCare and SingleCare members have a care coordinator available to assist with coordinating needed services. Care coordination is provided for you by local county social workers and nurses or a nurse and social worker within South Country Health Alliance for some members. A care coordinator can give you information about community services, help you find services to stay in your home or community and help you find services to move out of a nursing home or other facility. They can help you make appointments and coordinate services following hospitalization.

You can get information on care coordination services by calling Member Services at the phone number listed on the front cover of this book.

### Clinics

You can use any primary care clinic that’s listed in this directory or our online provider search at [www.mnscha.org](http://www.mnscha.org). South Country does not require that you choose a primary care clinic (PCC). Please confirm with Member Services that your clinic is still a provider with our health plan.

### Cost Sharing

You may be required to pay an amount toward some health care services. This called cost sharing. Some examples of cost sharing are copays or deductibles for certain services. You are responsible to pay your cost sharing amount directly to your pharmacy or healthcare provider. You can get a Member Handbook with more information about cost sharing.

### Interpreter Services

American Sign Language (ASL) and language interpreter services are available to help you get services. Oral interpretation can be given to you in your language. You may be able to get written information in your language. For assistance, call Member Services at the phone number listed on the front cover.

### Long Term Services and Supports (LTSS) *(for MSC+ members only)*

You may be able to get long-term services and supports (LTSS), such as services provided by the Elderly Waiver (EW) program as a South Country member. LTSS help people who need assistance to do everyday tasks like taking a bath, getting dressed, making food and taking medicine. LTSS are intended to help you live in the community and are typically provided at your home by Home and Community Based Services providers.

You must have a long-term care consultation (LTCC) done and be found to be eligible to get additional services or support. You can ask to have this assessment in your home, apartment, or facility where you live.

Your care coordinator will meet with you and your family to talk about your care needs if you call to ask for a visit.

Your care coordinator will give you information about community services, help you find services to stay in your home or community and help you find services to move out of a nursing home or other facility.

If you need transition planning and coordination services to help you move to the community, you may be eligible to get Moving Home Minnesota (MHM) program services. MHM services are separate from Elderly Waiver (EW) services, but you must be eligible for EW.

To find out more about these services, refer to your Member Handbook. Call Member Services at the phone number listed on the front cover to get more information on how to access these services.

### **Member Handbook**

To get detailed information about covered health care services, refer to your Member Handbook. It also explains your rights and responsibilities as a member of South Country Health Alliance. Contact Member Services at the phone number listed on the front cover of this book. You can ask for a printed copy of the Member Handbook at any time. ### **Member Identification (ID) Cards**

You will get a health plan member identification (ID) card. You must show this card whenever you get health care services, including when you get a prescription filled. Your Member ID cards will be mailed to you in the same envelope as your member packet.

This could include, but is not limited to, accessible office, exam room and equipment.

### **Prior Authorization**

Our approval is needed for some services to be covered. You must get our approval before you get certain services or before we pay for them. You can get a Member Handbook with more information about which services require prior authorization.
