Chapter 12

Member Enrollment

Overview

South Country Health Alliance recommends that providers verify member eligibility prior to providing services and submitting claims for South Country members. This chapter outlines options for providers to verify individual's enrollment in South Country.

Eligibility in Minnesota Health Care Programs

South Country administers benefits for the following Minnesota Health Care Programs:

- Medical Assistance (MA) for Families and Children (also referred to as PMAP)
- MinnesotaCare
- SeniorCare Complete (MSHO HMO D-SNP)
- Ability Care (SNBC HMO D-SNP)
- Minnesota SeniorCare Plus (MSC+)
- Single Care (Special Needs BasicCare-SNBC)
- Shared Care (Special Needs BasicCare-SNBC, secondary to Medicare)

Eligibility for these programs is determined at the prospective member's county and/or through the Minnesota Department of Human Services (DHS). Additionally, some of the above listed programs require eligibility for Medicare. Please refer to the MN DHS website for additional detail on program eligibility guidelines.

Verification of Enrollment

Providers must use the South Country portal or MN-ITS to verify member eligibility on the working day before or the day services are provided within the current month. Providers can verify member enrollment in South Country via the South Country provider portal at https://provider.mnscha.org/scha.provider.aspx or through MN-ITS. MN-ITS is the Minnesota Department of Human Services (DHS) eligibility verification and billing system for Minnesota Health Care Programs (MHCP) claims and other transactions. Providers must be MHCP-enrolled and MN-ITS registered to use MN-ITS (https://mn-its.dhs.state.mn.us). To register for MN-ITS visit the link listed above and click on the registration link.
